Suitable extinguishing media

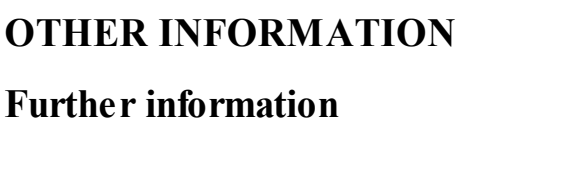
