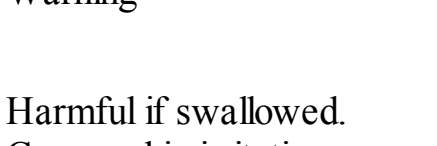

Hand protection
